## Duplication Policy for Commercial Use

### High-resolution digital reproductions

Digital files of **photographs or documents** are available in PDF (for documents) and TIFF (for photographs). Services for duplication of audio and video files are not available at present. The Permission to Publish Pictorial Material form must be submitted for use of images in publication, broadcast, public display, or on websites.

- Flatbed scanning on-demand: \$25.00 per image. (This applies only to images that have not already been scanned and are not yet in our records. Some restrictions apply with oversize images.)
- Images from [www.historylosgatos.org](http://www.historylosgatos.org): \$25.00 per image.

### *Procedure:*

1. Patron will submit the Permission to Publish Pictorial Material form.
2. Local History Librarian will review, notify patron of any issues, and send an invoice.
3. Patron will submit the payment (a check made out to the Los Gatos Library) in person or by mail.

Prepayment is required.

4. Local History Librarian will send the images to patron. Please allow up to two weeks after payment is received for delivery of on-demand scans, and 72 business hours after payment is received for delivery of images from [www.historylosgatos.org](http://www.historylosgatos.org).

The applicants must append the credit line to each published photograph. This credit line should appear with each individual image, not in a picture credits summary. The credit line is as follows:

### Conditions of Application

The undersigned request permission to publish specific pictorial materials physically owned by the Los Gatos Library. In order to receive permission, the undersigned agrees to the following:

1. I understand that this application is for a one-time, one-edition use. Any subsequent use requires resubmission of the Permission to Publish Pictorial Material form.
2. I will not use or authorize others to use the material or copies licensed herein, for any purpose whatsoever, without first obtaining a written letter of permission from the Los Gatos Library.
3. I agree to use the images provided without significantly altering it/them through conventional or electronic means. Altering or manipulating the image requires permission from Los Gatos Library. Images used on a website must be at a resolution of 72 dpi or less.

4. I understand that authorization to publish is not exclusive and the Los Gatos Library does not thereby surrender its own right to publish or to grant others permission to do so.
5. I agree to use the department's credit line, which must accompany each individual image published. This credit line should appear with each individual image, not in a picture credits summary.
6. I agree to pay any charges required by this request.
7. I understand that the Los Gatos Library makes no representation of exclusive ownership of the rights to any image. The user assumes all responsibility for conforming with the laws of libel and copyright, which may apply to the use of this material. It is not my intention to publish or otherwise reproduce any materials which are possibly subject to copyright without first having obtained written permission:
  - (a) from the copyright owner, his heirs, or assigns, and
  - (b) the Los Gatos Library, owner of the original materials.

This institution reserves the right to refuse permission to publish pictorial materials if, in its judgment, publication would involve violation of copyright law or would cause irreparable damage to valuable and fragile originals.
