CODE COMPLIANCE BI-ANNUAL REPORT
July – December 2025

This Code Compliance report summarizes activities for the second half of 2025 (July 1 through December 31, 2025).

A total of 282 Notices of Violation were issued in the six-month reporting period. Of these 282 notices, 164 were violations of the Noise Ordinance (58 percent of all violations). Within the noise violation category above, gasoline powered leaf blowers continue to be the single most frequent violation in the Town at 144 violations. The miscellaneous violation category was the second highest category with 30 violations. 13 stop work notices were issued in the reporting period for construction without a permit. In the first half of 2025, only five stop work notices were issued.

Code Compliance also responded to three potentially dangerous trees concerns, eight corner sight triangle violations, and three illegal dumping referrals from Public Works staff.

The Los Gatos Monte Sereno Police Department referred three homeless encampments to Code Compliance and one social host violation during the reporting period. All three homeless encampments have been cleared, and the social host violation appeal has been set for February 13, 2026.

During the reporting period, the Special Council to the Town Attorney's Office and Code Compliance held seven Administrative Hearings before a Hearing Officer. The hearings were regarding three homeless encampments, one dilapidated roof, one hoarding condition, one illegal signage display, and one building permit hearing. The Hearing Officer upheld all Compliance Orders and five of the violations were resolved.

Table 1 indicates that overall violations have increased from 185 to 282 when compared to the previous reporting period. Of the 282 violations issued during the second half of 2025, only 29 are still active.

Table 2 shows that the number of citations issued increased by 31.82%. Violations resulting in litigation have decreased by one, and referrals to the Town Attorney have increased by 40.00%.

In early October 2025, Code Compliance staff were made aware of a prohibited retail business (head shop) moving into a downtown location. In coordination with Economic Development, Police, and Planning; we were able to contact the property owner, issue the business owners notice regarding the prohibited business, and cease the business from opening.

Table 3 details the types of complaints filed with the Town. Compared to the previous reporting period, the number of Code Compliance phone calls decreased by 11.86%, the number of online complaints has increased by 21.54%, and the total number of violations have increased by 52.43% from the previous reporting period.
