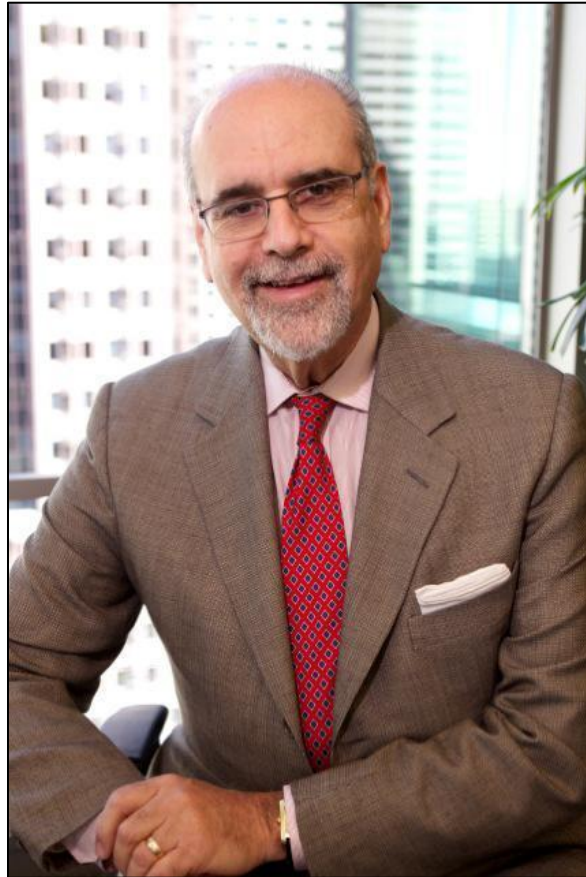


## Matthew Hudes Bio
