

LOS GATOS-MONTE SERENO POLICE DEPARTMENT  
BINGO PERMIT APPLICATION

Those organizations declared eligible under Article V. Bingo Division 1. Section 3.50.010 of the Town Code, may if issued a permit under the provisions of this chapter, conduct bingo games in the Town.

Applications for a permit to conduct bingo games shall be made by a member of the staff of the permittee organization who will be participating in the promotion, or supervision of such game.

The application for a bingo permit shall show:

The name of the applicant, a statement of the purpose for which the applicant is organized and that applicant is an eligible organization under specified parts of Revenue and Taxation Code section 23701d and Internal Revenue Code section 170(c)(2).

The name and address of all officers of the applicant, and the signature of an officer duly authorized to make the application.

The particular property, including the street number, owned or leased by the applicant and used by the applicant for an office or for performance of the purposes for which the applicant is organized, where bingo games are proposed to be conducted, and the occupancy capacity of the building or portion of a building proposed to be used for bingo games.

The days of the week and hours of the day proposed for conduct of bingo games.

An agreement by the applicant to conduct bingo games in strict accordance with the provisions of section 326.5 of the Penal Code and this Article, as they may then exist or be amended from time to time, and that the permit to conduct bingo games may be revoked by the Police Chief upon violation of any of such provisions, or any violation of any statute or ordinance when the violation is related to the conduct of bingo games, concerning public safety or welfare, the use of land or buildings, or moral turpitude.

The applicant shall submit with its application a Certificate of Determination of Exemption under section 23701d of the Revenue and Taxation Code or a letter of good standing from the Exemption Division of the Franchise Tax Board in Sacramento, showing exemption under section 23701d.

The names and addresses of all persons who will conduct bingo games or who will have custody of the records of the conduct of and money received from bingo games.

The application shall be signed by the applicant under penalty of perjury.
