The Commission consists of seven (11) adult commissioners, one (1) Arts and Culture Commissioner, one (1) Community Health and Senior Services Commissioner, seven (7) Los Gatos residents, Los Gatos business owners, Los Gatos business employees, Los Gatos faith leader, or Los Gatos non-profit employee. Each member is appointed by the Town Council, with the exception of the Arts and Culture Commissioner and, Community Health and Senior Services Commissioner, who are appointed by their respective commissions.
