
# ENTERTAINMENT ZONE

## SB 969- WIENER. ALCOHOLIC BEVERAGES: ENTERTAINMENT ZONES: CONSUMPTION

- Jurisdictions may adopt an Entertainment Zone Ordinance
  - Allows specific types and sized open containers of alcoholic beverages to be carried and consumed on public right-of-way within the Entertainment Zone with an approved permit.
- All beverages must:
  - Be purchased during the activation from an established ABC licensed location physically located within the zone.
  - No tents, pop up carts, or outside licensees may sell or dispense within the zone. Unable to be combined with an ABC Temp Event Permit.
  - No deliveries by licensee or 3<sup>rd</sup> parties is permitted, except to private residences or private property
- Each EZ activation/event requires approval through a permitting process.

# ENTERTAINMENT ZONE

## ABC MUSTS



- Adopt an ordinance → TC to consider on 2/3
- Establish a process to easily identify 21+ → wristbands
- Identify the boundaries → Downtown
- Max Days/Hours of operation → 8am to 10pm, proposed
- Types of alcoholic beverages permitted
- Approved nonglass & nonmetal containers → uniform plastic cup, researching options
- Businesses must get ABC approval individually and annually, provide copy to the Town → this will be checked prior to permit approval

# What's our process?

*The Town's process will be further defined and communicated once the item is considered by the Town Council.*

- Special Event Permit Application
  - Filed in advance, 60 days minimum
- Conditional Letter of Approval
  - Day, hours, map, locations & EZ signage and conditions applied
- Entertainment Zone Requirements:
  - Cups
  - Wristbands
  - Signage at each participating establishment
  - Boundary signage/barricades
  - Ambassadors or event volunteers may be required

# What types of activations could work?



EZ activation cannot be combined with a temporary ABC event permit or BYO “*beer or wine with a picnic lunch*” as permitted at Plaza Park or the Civic Center – often observed during Jazz and MIP.

Businesses will need to work together to activate the Entertainment Zone!

# parklets... quick review!

## **Businesses operating parklets are responsible for:**

- Maintaining COI that meets Town standards AND providing the updated COI to the Town Clerk's office annually.
- Maintaining an open air, al fresco dining environment unless an approved BP is obtained. This includes installing roofs, covers, pergolas, and other similar structures.
- Ensuring no signs, banners, fabric, plastic, or other materials hang vertically from the parklets at any time.
- Maintaining an open and accessible parklet for the public during non-business hours.
- Clearing any debris that collects in the gutter against the parklet and between the curb and parklet to avoid flooding and maintain storm drain standards.
- Following the Santa Clara County Fire Dept. regulations for heaters in public.
- Maintaining ADA access in and around the parklet.
- Parklet use does not allow for sidewalk use. The public sidewalks must remain free and clear of tables, planters, seating, furniture and other items unless an approved outdoor dining or encroachment permit have been issued.
